

Headline and Core Inflation:¹ December 2024

- Annual urban headline inflation declined to 24.1 percent in December 2024, down from 25.5 percent in November 2024, marking its lowest rate in two years. This decline is primarily attributed to food inflation, which steadily decreased throughout 2024. In December 2024, the decline in prices of fresh vegetables outweighed the increase in non-food inflation.
- Annual core inflation remained broadly stable at 23.2 percent in December 2024 compared to 23.7 percent in November 2024. Monthly core inflation registered 0.9 percent in December 2024, compared with 1.3 percent in December 2023 and 0.4 percent in November 2024. Monthly inflation reflects mild increases in retail and services inflation, including expenditures on restaurants and cafes, as well as rents.
- Monthly urban headline inflation recorded 0.2 percent in Decemeber 2024, compared with 1.4 percent in December 2023, and 0.5 percent in November 2024. This slowdown is driven by a stronger decline in fresh vegetable prices compared to their usual seasonal pattern, offsetting the increase in non-food inflation caused by internet and mobile services, pharmaceutical products, and other non-food items.
- Annual rural headline inflation decelerated to 22.8 percent in December 2024, down from 24.4 percent in November 2024. Similarly, annual nationwide headline inflation slowed down to 23.4 percent in December 2024, down from 25.0 percent in November 2024.





Figure 1. Headline and Core CPI Inflation

¹ Headline inflation is published by the Central Agency for Public Mobilization and Statistics (CAPMAS), while core inflation is computed by the Central Bank of Egypt. CAPMAS publishes three CPI series: (1) CPI-urban areas, which includes Cairo, Alexandria, urban Lower Egypt, urban Upper Egypt, Canal cities and Frontier governorates, (2) CPI-rural areas, and (3) CPI-all areas. Numbers quoted in this note refer to CPI-urban.



Monthly Inflation Developments

Key Highlights:

- Prices of fresh fruits increased by 7.1 percent, while fresh vegetable prices declined by 16.3 percent, which is stronger than their seasonal pattern. Combined, they contributed negative 0.61 percentage point to monthly headline inflation.
- Prices of **poultry** and **eggs** decreased by 0.1 percent and 3.4 percent, respectively. Combined, they contributed negative 0.07 percentage point to monthly headline inflation.
- Prices of dairy products increased by 0.6 percent, contributing
 0.03 percentage point to monthly headline inflation.
- Prices of oils and fats increased by 0.8 percent, contributing
 0.02 percentage point to monthly headline inflation.
- Prices of other core food items—including red meat, market sugar, pulses, confectionary, and market tea—contributed
 0.03 percentage point to monthly headline inflation.
- Prices of services increased by 1.5 percent, contributing 0.42 percentage point to monthly headline inflation. This was mainly driven by recent price increases in mobile phones and internet services, higher expenditure on restaurants and cafes, as well as higher rents, among other services.
- Prices of retail items increased by 1.7 percent, contributing
 0.23 percentage point to monthly headline inflation. This was mainly driven by clothing and footwear, vehicle purchases, personal care products, and household cleaning products, among other retail items.
- Prices of regulated items increased by 0.8 percent, contributing 0.16 percentage point to monthly headline inflation. This is mainly attributed to recent price hikes in pharmaceutical products and public transportation.

Figure 2. Contribution to Annual Headline CPI Inflation







Figure 3. Contribution to Monthly Headline CPI Inflation





Figure 4. Contribution to Annual Core CPI Inflation (in percentage points)



Monthly core inflation was affected by the aforementioned developments in core CPI items. **Core food** items contributed 0.02 percentage point to monthly core inflation, while **retail items** and **services** contributed 0.32 and 0.58 percentage point to monthly core inflation, respectively.
